- v. The Engagement is on full time basis and they will be paid consultancy fees as per the rules in vogue.
- vi. The decision of the Competent Authority regarding selection of candidates will be final and no representation will be entertained in this regard.
- vii. Applications incomplete in any aspect will be summarily rejected.
- viii. The Competent Authority also reserves the right of any amendment, cancellation and changes to this advertisement as a whole or in part without assigning any reason or giving notice.
- ix) The applicants who have already submitted their application for the above engagement need not apply again.

2. Terms and Conditions:

- i) The Consultancy service will be on full time basis initially for a period of six months and consultancy fee will be paid as per the rules in force.

PROFORMA FOR AGREEMENT TO BE EXECUTED WITH THE CONSULTANT ENGAGED ON CONTRACT BASIS

This AGREEMENT on this day of _____ BETWEEN the PRESIDENT OF INDIA through the Examiner, Director of Accounts and Treasuries, Directorate of Accounts and Treasuries, Government of Puducherry (hereinafter called the Employer which expression shall unless excluded by or repugnant to the context, be deemed to include his successors in office and assigns) of the one part and _____ (Name and address) (hereinafter called the Appointee) of the other part.
