Kind attention of the Heads of Autonomous Organizations is invited to the references cited above. In compliance to the order communicated by the Finance Department vide reference 1st cited, the Autonomous Organizations receiving Grant-in-Aid from Govt. of Puducherry have opened Single Nodal Agency (SNA) accounts in Scheduled Commercial Banks. Further, the banks have also been directed to develop a digital platform similar to Public Financial Management System (PFMS) for the funds released from the Consolidated Fund of Union Territory of Puducherry according to the operational framework enumerated in the O.M. dated 13/04/2022. Accordingly, the banks have developed a digital platform in consultation and coordination with the officials of DAT, and they are ready to go live.

Though the Finance Department has directed the Autonomous Bodies to utilize the digital platform developed by the concerned Bank wherein they have opened SNA account and onboard their account immediately in any case not later than 31/05/2024 vide reference 3rd cited, only two institutions have on boarded their accounts in the digital platform. Despite repeated requests and reminders, the autonomous organization have failed to comply with the instructions and not yet on boarded their accounts in digital platform. Delay in utilizing the digital platform leads to ineffective cash management and adversely affects the transparency in Public Expenditure Management besides stopping further release of GIA. Therefore, all Autonomous Organizations are requested to onboard their state SNA in the digital platform developed by the concerned Bank without any further delay.

A compliance Report in this regard shall be submitted to this Directorate on or before 20.04.2025.
