ORDER

Sub: DAT – S.K. Estt. – Seniority List of Store Keeper Gr.III –
Speaking Order in compliance of the Order dated
25.03.2022 of the Hon'ble CAT, Chennai Bench in
MA/310/00159/2022 in & OA/310/00245/2022 – Issued.

The Tentative Seniority list of Store Keeper Grade-III, was communicated to all the officials concerned calling for objections, if any, to the tentative seniority assigned to them, vide Memorandum dated 31.01.2022. In response, the Store Keeper Grade-III who were appointed during 2015 have submitted representations with a request to include them inter-se with the candidates appointed during 2013 as per the selection merit.

2. Simultaneously eleven Store Keeper Grade-III namely, Tvl. S. Rethinasamy and 10 Others have filed MA/310/00159/2022 in & OA/310/00245/2022 in Hon'ble Central Administrative Tribunal with the following prayer:

" To direct the respondents to consider the individual representation/objections dated 07.02.2022, 08.02.2022 & 09.02.2022 submitted by the applicants and take appropriate action to redraw/revise impugned Draft/Tentative Seniority List vide Memorandum No.11-1/DAT/S.K.Estt./S.K.Gr.III/2021/08, dated 31.01.2022 issued by the 4th respondent for the post of Store Keeper Grade-III and publish final seniority list for the post of Store Keeper Grade-III by fixing and assigning seniority purely based on merit irrespective of their date of appointment since all the candidates, whose names were found place in the impugned Tentative Seniority List dated 31.01.2022, were selected through a single source of competitive examination by strictly adhering to the guidelines issued by the DoPT, Government of India under various OMs and law laid down by the Hon'ble Apex Court in various judgements in this regard and till such time direct the respondents to maintain status quo and not to finalize Draft/Tentative Seniority List for the post of Store Keeper Grade-III and preparation of empanelment list for granting promotion to the post of "Store Keeper Grade-II" from feeder category post of Store Keeper Grade-III and pass such further or other order as this Hon'ble Tribunal may deem fit and proper in the circumstances of case and thus render justice."

3. The Hon'ble Central Administrative Tribunal disposed of the O.A. on 25.03.2022 with the following direction:-

"In view of the limited submission, without going into the merits of the case, the respondents are directed to consider the representations of the applicants dt. 07.02.2022, 08.02.2022 and 09.02.2022 at Annexure A7 and pass a reasoned and speaking order as per law within a period of two months from the date of receipt of a copy of this order."

4. In compliance with the Orders of the Hon'ble Central Administrative Tribunal the representations submitted by the applicants and other similarly placed were examined with reference to the DoPT guidelines and accordingly, tentative seniority list issued on 31.01.2022 has been revised. The revised tentative seniority of Store Keeper Grade-III has also been communicated vide Memorandum dated 25.04.2022, calling for objections, if any from the stake holders.

5. With this the representations stand disposed of.
